### **Results of Annual Shareholder Meeting**

SOMERSET, PA (May 22, 2026) - Somerset Trust Holding Company (OTCQX: SOME) (the “*Company*”), the holding company of Somerset Trust Company (the “*Bank*”), held the Annual Meeting of its shareholders at the Bank’s Historic Trust Building in Somerset, Pennsylvania, on Tuesday, May 19, 2026, beginning at 2:00 PM (the “*Annual Meeting*”). The requisite number of shares were represented at the Annual Meeting, either in person or by proxy, to constitute a quorum.

### **Board Size**

At the Annual Meeting, a majority of the shares of the Company’s Common Stock that were present and voted, either in person or by proxy, voted to fix the number of Directors to serve on the Company’s Board of Directors for the next year at Eight (8).

### **Election of Directors**

At the Annual Meeting, a majority of the shares of the Company’s Common Stock that were present and voted, either in person or by proxy, voted for the election of each of Sean M. Cook and Jesper P. Nielsen to the Company’s Board of Directors. Each of these Directors previously served on the Board of Directors and each has been elected to serve a three-year term.

### **Ratification of the Selection of External Auditor**

At the Annual Meeting, a majority of the shares of the Company’s Common Stock that were present and voted, either in person or by proxy, voted for the ratification of the selection of Forvis Mazars, LLP, as the Company’s independent registered public accounting firm for the fiscal year ending December 31, 2026. The decision to retain Forvis Mazars, LLP had been previously approved by the Audit Committee and reported to the full Board of Directors.

### **Annual Organizational Meeting of the Board**

The Board of Directors of the Company held its annual organizational meeting on May 21, 2026

in Somerset, Pennsylvania. At such meeting, the Board of Directors took the following actions:

### **Election of Chairman and Vice Chairman of the Board**

The Board of Directors of the Company elected Sean M. Cook and Vickie L. Beer to serve as Chairman and Vice Chairman of the Board of Directors, respectively.

### **Appointment of Officers**

The Board of Directors of the Company appointed the following individuals to serve as officers of the Company: Sean M. Cook as President, Christopher R. Robbins as Secretary, and Jennifer A. Sheeler as Treasurer and Chief Financial Officer.
